Discussion Item	Recreation Committee Interview – Susan Wood																
Background	<p>The Recreation Committee was reestablished as a statutory committee by Ordinance 2008-4 to advise the City Council on matters pertaining to recreation programs and facilities.</p> <p>The ordinance provides that the Committee shall consist of seven to 15 Takoma Park residents appointed by the Council. Every effort shall be made to ensure that the membership represents all wards and the diverse populations in Takoma Park. Committee members will serve staggered two-year terms, with initial appointments of one and two years.
